Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share and protect your personal information. Please read this notice carefully to understand what we do.
	The types of non-public personal information we collect and share depend on the product or service you have with us. How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information the reasons Walter Investment Management Corp. chooses to share, and whether you can limit this sharing.

How does Walter Investment protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> ▪ sharing for affiliates' everyday business purposes --- information about your creditworthiness ▪ affiliates from using your information to market to you ▪ sharing for non-affiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing.</p>
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account — unless you tell us otherwise.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. Our affiliates include financial companies such as Ditech Financial LLC; Reverse Mortgage Solutions, Inc.; Green Tree Credit LLC; Green Tree Loan Company; Green Tree Insurance Agency of Nevada, Inc.
Non-affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. Walter Investment Management Corp does not share with non---affiliates for them to market to you.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Walter Investment Management Corp does not share with non---affiliates for joint marketing purposes.
